Please ensure that ALL "must have" items are included with your Building Permit Application. This will help us to process all permit applications as quickly as possible.

## Incomplete applications will not be accepted. Review the requirements carefully.

# **BUILDING PERMIT APPLICATION FORM**

- **Building Permit Application Form**
- Don't forget to include the Value of Construction, as this is used when we calculate your building permit fee. Building Permit Fees are paid when you PICK UP your permit.
- Don't forget to check the Zoning for your property to make sure you can meet the requirements.
- Zoning Bylaw and Map •
- Historic Building Permit File Information
  - The Town may have a site survey or drawings from a previous building permit application. Some costs may apply. Records may be available after 1970

# SITE SURVEY AND HEIGHT CALCULATIONS (required for all applications)

- Information for Surveyors
- Building siting is to be based on a survey prepared by a BC Land Surveyor (BCLS)

# DRIVEWAY ACCESS PERMIT APPLICATION

- Driveway Access Permit Application
- Please ensure that the driveway meets the Town's specifications including the maximum grade of the driveway shall be 20% with a change in rise or fall not exceeding 6% for each horizontal 3.5 m. The rise or fall of the driveway shall begin 2 m behind the curb towards the property. Refer to the Town of Ladysmith Engineering Standard R10 Typical Driveway Grades.
- Ensure that a driveway location, length, width, elevations, parking area and profile are shown on your Site Survey

### CONSTRUCTION PLANS (required for all applications)

- Provide your plans on plain white paper with a scale (1/4"=1').
- Guide for Seismic Design of Houses and Lateral Loads Information
- Spatial Separation Requirements and Fire Response Time
- Radon Rough-In Requirements Bulletin

#### ENGINEERED TRUSS DOCUMENTS

• Depending on the point loads and/or spans, a Structural Engineer may be required.

### ENGINEERED FLOOR SYSTEM LAYOUTS AND BEAMS

• Depending on the point loads and/or spans, a Structural Engineer may be required.

# PLUMBING ISOMETRIC DRAWING

• A plumbing isometric drawing shows the plumbing design of the drain, waste, and venting (DWV) system.

### **HAZARDOUS MATERIALS DECLARATION (Renovations & Demolitions)**

- Hazardous Materials Declaration Form
- Confirmation of Abatement Report or an Air Clearance Report may be required.
- Air Clearance Reports may be required at various stages of construction.
- Asbestos Certification and Licensing Requirements
