NOTICE OF A PUBLIC HEARING

Zoning Bylaw Amendment Bylaw No. 2169 January 21, 2025, 5:30pm

Pursuant to Section 466 of the *Local Government Act*, we advise you that a Public Hearing has been scheduled to consider these amendments to the Zoning Bylaw. Anyone who considers their interest in property to be affected by the proposed Bylaw will be given reasonable opportunity to be heard.

Subject Properties

Bylaw No. 2169 will apply to designated single-family dwelling properties within the following zones: RU-1; R-1; R-1-A; R-2; R-2-B; or R-3.

What is the Proposal About?

If approved, Bylaw No. 2169 will amend the Zoning Bylaw to accommodate the regulations within the proposed "Town of Ladysmith Animal Control Bylaw 2024, No. 2167", including allowing backyard poultry (female chickens and ducks) on certain single-detached dwelling residential properties and using goats for vegetation management. The proposed amendments to the Zoning Bylaw include:

- 1. New and amended definitions for 'Backyard Poultry', 'Coop', and 'Pen', 'Fence', and 'Produce Stand'.
- 2. Regulations allowing the sale of 'Backyard Poultry' eggs.
- 3. Changes to regulations for 'Accessory Buildings or Structures' to allow 'Coops' and 'Pens'.
- 4. Regulations allowing temporary accommodation (30 consecutive days maximum) and vehicle storage to provide shelter for a wrangler and animals, such as goats, used for vegetation management.
- 5. Regulations allowing the keeping of up to six 'Backyard Poultry' as an 'Accessory Use' in the RU-1, R-1, R-1-A, R-2, R-2-B, and R-3 zones outside of the 'Backyard Poultry Exclusion Area Schedule A of "Town of Ladysmith Animal Control Bylaw 2024, No. 2167".
